Terms of the contract with the Vendor _____ Date _____ From this date forward:

- ❖ Each vendor is responsible for leaving his or her space cleaned, in the same condition that it was found. With this in mind food vendors must protect the floor of their space with a (plastic/tarp) covering.
- ❖ Each vendor must have all the utensils and equipment for their booth (tables, chairs, etc.)
- ❖ Vendors should let us know ahead of time the number of electrical outlets needed (# _____)
- ❖ Each standard booth (10' x 10') will have no more than two (2) people working at any given time. Each large booth (10' x 20') will have no more than four (4) people working at any given time.
- ❖ If the Booth vendor needs a larger space, the cost is \$5 USD per square foot per day.
- ❖ To secure your booth, pay in full, or 50% of the cost and the remainder by July 31, 2018.
- ❖ COMPENSATION: All vendors and their employees/assistants, maintain inoffensive against their directors, officials, employers, agents and EXPOBOL representatives of all responsibility, obligations, damage, penalties, claims, costs, charges, and expenses (including reasonable costs of lawyers) and keep them free of any obligation of any natural damage, including personal injuries or lost, lost of properties caused by users, including visitors, representatives and participants, in connection with any chaos, occupation and action of work allowed in this agreement. In the event of bad weather, rain, storm, or any natural disaster, EXPOBOL will not be responsible to return or compensate any payment to vendors, sponsors or general users.
